

**VILLAGE OF ST. CLOUD, FOND DU LAC COUNTY, WISCONSIN,
ORDINANCE TITLE 10, SECTION 9**

**AN ORDINANCE APPROVING AND ADOPTING THE
VILLAGE OF ST. CLOUD COMPREHENSIVE PLAN 2009-2029**

WHEREAS pursuant to the provisions of Section 66.23(2) and (3) of the Wisconsin Statutes, the Village of St. Cloud is authorized to prepare and adopt a Comprehensive Plan for the Village's vision of the future growth and development of the community as defined in Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes; and

WHEREAS the Village Board of the Village of St. Cloud, Wisconsin, has previously adopted written procedures designed to foster public participation in every stage of the preparation of the comprehensive plan as required by Section 66.1001(4)(a) of the Wisconsin Statutes; and

WHEREAS the Village of St. Cloud, through its Plan Commission and through community participation, with the assistance of Martenson and Eisele, Inc., has, between May of 2008 and June of 2009, prepared, developed and drafted a proposed Comprehensive Plan for the Village of St. Cloud; and

WHEREAS the Village of St. Cloud Plan Commission has, by majority vote of the entire Plan Commission, as recorded in its official minutes, adopted a resolution recommending to the Village Board the adoption of the document entitled "Comprehensive Plan 2009-2029, Village of St. Cloud, Fond du Lac County, WI", a copy of which document is on file in the Office of the Village Clerk, which contains all of the elements required under the provisions of Section 66.1001(2) of the Wisconsin Statutes; and

WHEREAS the Village Board has held a public hearing to solicit further input on the proposed 2009-2029 Comprehensive Plan as required under the provisions of Section 66.1001(4)(d) of the Wisconsin Statutes;

NOW, THEREFORE, THE VILLAGE BOARD OF THE VILLAGE OF ST. CLOUD, WISCONSIN, DOES ORDAIN AS FOLLOWS:

SECTION 1: That the "Comprehensive Plan 2009-2029, Village of St. Cloud, Fond du Lac County, WI" be, and the same hereby is, authorized, adopted and approved as the comprehensive plan of the Village of St. Cloud, Wisconsin, pursuant to the provisions of Section 66.1001(4)(c) of the Wisconsin Statutes and shall serve as the Comprehensive Plan of the Village of St. Cloud, Wisconsin, from the effective date of this Ordinance.

SECTION 2: That a true, correct and complete copy of the Comprehensive Plan shall be maintained in the Office of the Village Clerk of the Village of St. Cloud and shall be available for public inspection during all regular business hours of that office.

SECTION 3: That the appropriate officers and officials of the Village of St. Cloud be, and the same hereby are, authorized to take all such other and further action as they shall deem necessary or appropriate under and pursuant to the provisions of Section

66.1001 of the Wisconsin Statutes to implement and carry out the terms and provisions of the Comprehensive Plan for the effective growth and development of the Village of St. Cloud as envisioned under and pursuant to the Comprehensive Plan.

SECTION 4: That all ordinances or parts of ordinances in conflict herewith be, and the same hereby are, repealed.

SECTION 5: That this ordinance shall take effect immediately upon the passage and publication of the same as made and provided by law.
